

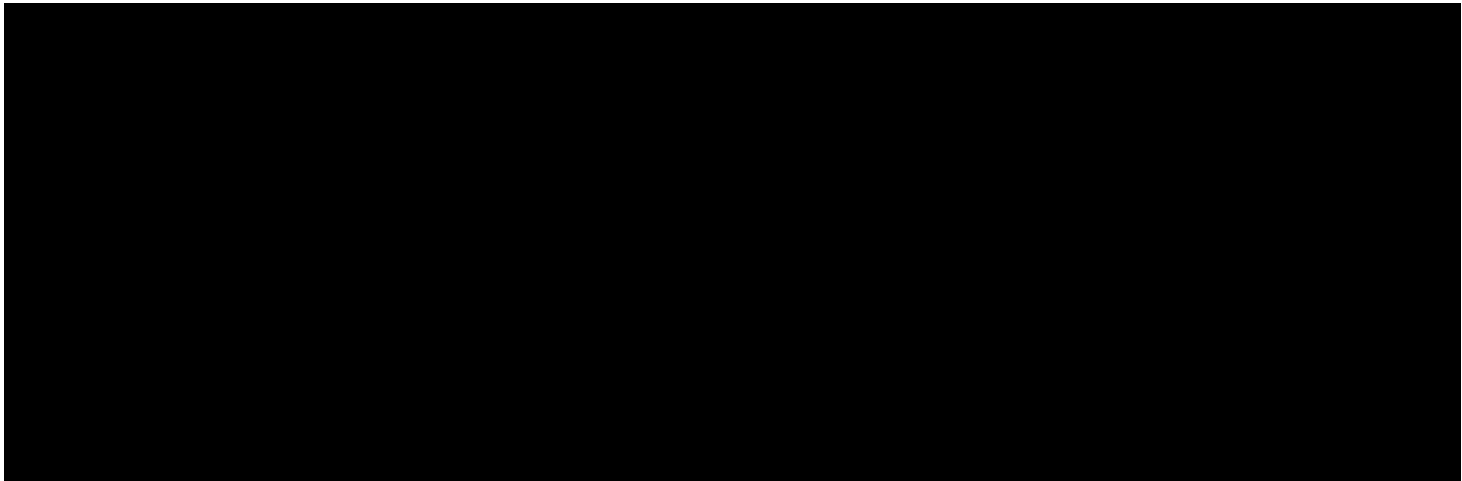

Dear Project holders,

Further to our mail of 16<sup>th</sup> September, 2022, we have been instructed by Special Audit Team that

a) no payment will be made to individuals (Aurovilians / non Aurovilian employees / temporary labour) without getting Aadhar number, bank details (if available) and Pan numbers.

b) Cash payment to individual is limited to only Rs.10,000/- vide below notification:

**Reduction in the limit of Cash Payment to Rs. 10000/- in a Day [Section 40A(3) & 40A(3A) of the Income Tax Act, 1961]** – reproduced below

The monetary limit on revenue expenditure in cash has been **reduced from Rs.20,000 to Rs.10,000** (there is no change in the monetary limit pertaining to cash payment upto Rs. 35000/- to Transport Contractors). Few exceptions are also provided in Rule 6DD of the Income Tax Rules. Consequently, any expenditure in respect of which payment (or aggregate of payment made to a person in a day), otherwise than by an account payee cheque/ draft/ use of electronic clearing system through a bank account, exceeds Rs. 10000/-, **no deduction shall be allowed in respect of such payment** under section 30 to 37 of Income Tax Act, 1961.

**More than Rs.10,000/- bank detail is required.**

We request you to strictly follow this and mention the KYC details in the payment vouchers.
